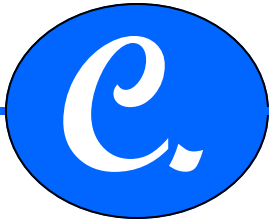

Banquet Menu & Contract

Thank you for choosing one of our three venues to hold your special event. We ensure that our staff will provide you with quality service and attention to detail and to make your event feel unique. AH Blank Golf Course can seat up to 280 guest with round tables and 350 with banquet tables. Waveland golf course seats up to 100 people with banquet tables. Listed below are the policies and fees of all three facilities.

- All Food and Beverage must be purchase from our facility. No food or alcoholic beverages may be removed from the banquet facility. An 18 % gratuity fee and sales tax will be added to all food and beverage charges on the final bill.
- The Iowa Liquor Commission regulates the sales and service of alcoholic beverages at our facilities. All alcoholic beverages must be served by our staff. We reserves the right to refuse service to any guest at anytime.
- Menu arrangements and a guest estimate are required at time of contract signing. A final count guarantee is required 14 days prior to the scheduled event date. The final count guarantee will be the number charged on the final bill plus any additional guests added .
- A deposit of **\$250.00** is due on the day of signing the contract. This is nonrefundable after fourteens days.
- Payment must be made in full to the Facility on the day before the event. Any beverage charges on the day of the event must be made in full immediately after the event.
- Any damages to the banquet facility or property of the facility prior to, during, or after the event by any participant in the event will be responsibility of the party signing the contract.

- Full bar service: with two bar tenders

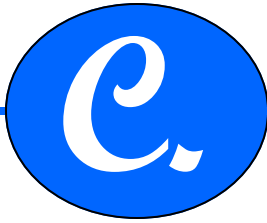
Decorations
